## Purchase of treasury shares

*Milan, 26 February, 2019* – MailUp S.p.A. – MAIL (the "**Company**" or "**MailUp**"), a company admitted to trading on the multilateral trading facility *AIM Italia / Alternative Investment Market* and operating in the *marketing technology field*, in the context of the resolution of the Company's General Shareholders Meeting on 26 April 2018, hereby notifies the purchase of n. 4,680 treasury shares on AIM Italia, value dates 20 and 22 February, 2019, at an average price of Eur 2.78 per share, for a total consideration of Eur 13,010.39.

The purchase was completed through Banca Popolare di Sondrio.
