Purchase of treasury shares

Milan, 9 May, 2019 – MailUp S.p.A. – MAIL (the “Company” or “MailUp”), a company admitted to trading on the multilateral trading facility *AIM Italia / Alternative Investment Market* and operating in the *marketing technology field*, in the context of the resolution of the Company’s General Shareholders Meeting on 26 April 2018, hereby notifies the purchase of n. 1,400 treasury shares on AIM Italia, value date 8 May, 2019, at an average price of Eur 3.14504 per share, for a total consideration of Eur 4,403.05.

The purchase was completed through Banca Popolare di Sondrio.
