### Purchase of treasury shares

Milan, 11 June, 2019 – MailUp S.p.A. – MAIL (the “Company” or “MailUp”), a company admitted to trading on the multilateral trading facility *AIM Italia / Alternative Investment Market* and operating in the *marketing technology field*, in the context of the resolution of the Company’s General Shareholders Meeting on 18 April 2019, hereby notifies the purchase of n. 4,700 treasury shares on AIM Italia, value dates 5 and 7 June, 2019, at an average price of Eur 3.2831 per share, for a total consideration of Eur 15,430.7630.
